



Fuchu City Board of Education

In March 2026, Fuchu City will provide an entrance fee to families with children who will be entering the first grade of a public or private elementary school in the city in April.

◇What is the Entrance Fee?

The Entrance Fee is one of school assistance fees.

This program is designed to help parents who have financial difficulties in paying educational expenses.

Only the Entrance Fee is provided prior to enter elementary school.

1. Those who are eligible for the entrance preparation fee

You must meet all of the following conditions

◆Those who live in Fuchu City as of February 1, 2026 (except for those who move out of Fuchu City before March 31, 2026).

◆Those who meet any of the criteria for the 2025 school assistance fees

- (1) Public Assistance has been suspended or discontinued (within 3 months of the suspension or discontinuation)
- (2) All members of the household are reduced or exempt from municipal tax
- (3) Personal business taxes have been reduced
- (4) Property taxes have been reduced
- (5) The national health insurance tax is reduced or deferred
- (6) Receiving child rearing allowance
- (7) Receiving a welfare loan except for loan by COVID-19.
- (8) Affected by disaster such as the Great East Japan Earthquake
- (9) the total income of the household is as follows

- ◆ If you wish to receive assistance other than the Entrance Fee, please apply for the 2026 Schooling Assistance Fee after entering elementary school.
- ◆ If you moved out on or after February 2, 2026, we will notify the local government of the transferee municipality that you have received the payment from this city to avoid duplication of payments.
