# How to apply for FY2024 Price soaring priority support benefit (¥30,000 /Household)

The Price soaring priority support benefit (30,000 yen per household) is a benefit to support households who are exempt from Resident-Tax and have experienced sudden changes in household finances, as prices of electricity, gas, food, and other items continue to soar.

#### **Benefit Amount**

## Period of payment

## ¥30,000/household

The payment will started from the Mid. March, 2025 sequentially.

# Households eligible for benefits

As of 13th December, 2024, they are registered as the resident of Fuchu City, and all the members of households are non-taxable for per capita levy of resident tax

The following households do not meet the eligibility criteria and will be excluded:

- Households consisting solely of those are dependent on other relatives (including full-time business workers) who are subject to inhabitant tax in FY2024.
  - Note: Whether an individual is a dependent will be determined based on their tax declaration for FY2024.
- Households with members who have not completed their resident tax declaration for FY2024 and have income equivalent to per capita levy of resident tax
- Households with members who have notified the application of exemption from inhabitant tax under the tax treaty for FY2024.
- Households that have received the Fuchu City Price soaring priority support benefits or similar benefit (30,000 yen) in other municipalities in this fiscal year, or included a head of household who was eligible for such benefits.
  - Notes: If it is determined after the payment of benefit that the eligibility requirements were not met, or if you are subject to the per capita levy of resident tax for FY2024 due to an amended tax return or other reasons, the benefits need to be returned.

## How to apply

### Eligible household that fits one of the following

Households that have received one of the following benefits from Fuchu City in the head of household's account

\*Only the household that is not changed the head of householder.

- •FY2023, FY2024 Temporary Special Benefits
- Price soaring emergency support benefit
- Price soaring priority support benefit
- •FY2024 Support payment for low-income households

## **Procedures for payment of benefits**

## I. Households corresponding to I in the from page

- Fuchu city will send the notification with your bank information and the date of transfer the benefit.
- If you don't have to change the bank account, please DO NOT return the form. The benefit will be transferred to the same bank account.
- If you would like to change the bank account, or to decline payment, please contact the call center by **February 28, 2025 at PM5:15.** 
  - \*If you do not contact us by the above deadline, the benefit will be transferred to the bank account indicated in the notice.

## **II.** Households corresponding to II in the from page

#### You must apply to receive benefits.

- Fuchu City will send the application form with the details of the payment and confirmation items to households deemed eligible.
  - There are two ways to apply.
  - **1** Online Application
    - Please check the contents of the application from (payment requirements, etc.) and apply using the 2D code (QR code)
  - 2 Application by mail
    - Check the details (such as eligibility requirements) in the confirmation form (application form) and send it back to Fuchu City.

Acceptance period for Confirmation Form: Monday February 17 to Saturday May 31, 2025 \*The application window is open from Monday February 17 to Friday May 30, 2025.
