As electricity, gas, and food prices continue to soar, Fuchu City provides the Price soaring priority support benefit to low-income households (households exempt from resident tax, etc.) whose finances are particularly affected.

Benefit amount

Period of payment

¥70,000/household

Payment is scheduled to be made sequentially from around late February 2024.

Households eligible for benefits

Households that are registered as a resident of Fuchu City as of December 1, 2023, and where all household members have a "non-taxable per capita rate of resident tax" in fiscal 2023.

How to apply

Eligible household that fits one of the following

Households that received either the "Temporary special benefit," the "Price surge emergency support benefit," or the "Price soaring priority support benefit (¥30,000)" from Fuchu City by bank transfer

Households other than those on the left

No need to apply

Fuchu City will send a notification with the bank account, transfer date, and other information.

Procedures for payment of benefits

I. Households corresponding to I on the front page

- Fuchu City will send the notification with your bank account and the date of transfer of the benefit.
- *The bank account will be the same as that used for the "temporary special benefit," the "price surge emergency support benefit," or the "price soaring priority support benefit (¥30,000)."
- If you don't need to change the bank account, please DO NOT return the form. The benefit will be transferred to the same bank account.
- If you would like to change the bank account or decline to receive the benefit, please apply using the form by the deadline below.

Submission deadline: Wednesday, February 14, 2024

*The benefit will be transferred to the bank account printed on the form if you don't return the form by the date above.

II. Households corresponding to II on the front page

- You must apply to receive the benefit.
- Fuchu City will send the application form to households deemed eligible.
- Check the form and confirm the conditions for the benefit, and then **send the application form** to Fuchu Citv.
- The benefit will be paid after 3 or 4 weeks from the day Fuchu city received the form.

Acceptance period: Thursday, February 1 to Tuesday, April 30, 2024
