Fuchu City School Lunch Replacement Subsidy

Fuchu City provides subsidies to parents/guardians of children who bring their own lunch as an alternative to school lunches.

1. Eligibility

This subsidy is available to parents/guardians of children enrolled in Fuchu City municipal elementary and junior high schools who bring their own lunches to school because they cannot eat the school lunches provided due to food allergies, illnesses requiring dietary management or other reasons.

- (1) Children who do not receive any school lunch, including beverages, and bring their own lunches to school.
- (2) Children who receive school lunch beverages such as milk, but eat the lunches they brought.

Note: Before applying for the subsidy, please complete the following procedures through your child's school if you have not already done so.

- O If you have unpaid school lunch fees from previous years (excluding those approved for installment payments in or deferred payments)
- O If your child eats lunch at home, alternative school (free school), or anywhere other than the municipal school where they are enrolled

2. Subsidy amount

The subsidy is calculated by multiplying the number of months during which lunch was brought by the monthly school lunch fee for the relevant school year.

Notes:

- 1. If your child will be receiving beverages, the cost of those beverages will be deducted from the monthly school lunch fee in the calculation. The specific amount will be determined in early May of each year.
- 2. August and September will be combined and counted as one month.
- 3. Subsidies will be issued in two installments: one for the first half of the school year (April to September) and the other for the second half (October to March). If you become ineligible for the subsidy due to moving out of the city or other reasons, however, the subsidy will be issued at that time.
- 4. If your child starts bringing his/her lunch in the middle of the month, you will be eligible for the subsidy starting the following month.
- 5. If your child stops bringing his/her lunch in the middle of the month, you will be eligible for the subsidy until the previous month.

3. Application procedures

Since subsidies are provided semiannually, you must complete procedures for both the first half of the school year (①) and the second half (②). Parents/guardians are responsible for completing the procedures for the shaded items in the table below.

^{*1:} The application date will be the date that Fuchu City receives the application form from the school. If you wish to apply in the middle of the school year, please submit your application by the tenth of the month in which you wish to begin receiving the subsidy.

Example: If you wish to receive the subsidy from June, please submit the application by June 10.

*2: The application form and notification of change are distributed at your child's school. You can also download them from the Fuchu City website.
